SGVRHT requests that persons addressing the meeting refrain from making personal, slanderous, profane or disruptive remarks. A person who continues to disrupt the orderly conduct of the meeting, after being warned by the Board Chair or designee to cease the disruption, may be precluded from further participation in the meeting.

TO ADDRESS THE GOVERNING BOARD: At a regular meeting, the public may comment: (i) on any matter within the jurisdiction of the Board of Directors that is not on the agenda during the public comment period at the beginning of the agenda; (ii) on any item(s) that is on the Consent Calendar prior to action taken on the Consent Calendar; and (iii) on any other agenda item prior to the time it is considered by the Board. during the public comment period and may also comment on any agenda item at the time it is discussed. At a special meeting, the public may only comment on items that are on the agenda. Members of the public are requested to state their name prior to speaking. Comments are limited to a maximum of three minutes per person. The Board President may impose additional time limits if comments become repetitious, an individual member of the public seeks to speak on numerous items, or a large number of members of the public seek to speak on an item. Except in limited situations, the Board may not take action on items not appearing on the agenda and/or discuss them at length.

RECOMMENDED ACTION

Adopt Resolution 23-13 authorizing the subordination of the RLF loan in the amount of \$4,000,000 for The Boulevard (Montebello).

BACKGROUND

At its July 2023 meeting, the San Gabriel Valley Regional Housing Trust (SGVRHT) Board of Directors approved a Revolving Loan Fund (RLF) loan for the Boulevard in Montebello. The Boulevard is an 81-unit affordable housing project for low-income and workforce families earning 30 to 80% Area Median Income (AMI). Thirty percent of the units will be reserved for survivors of domestic violence. The RLF loan will be used to acquire the property and is secured by the contracts and plans to complete the site which include the architectural drawings. At the time of RLF loan approval, it was noted that the SGVRHT would be the senior lender, however the cost of property acquisition exceeds the RLF loan. Century Housing is also providing a loan for acquisition and predevelopment expenses but requires first position. Century Housing is a Community Development Financial Institution (CDFI) that provides loans to affordable housing developments in California and has requested that the SGVRHT sign a subordination agreement.

The RLF guidelines allow for RLF loans to be subordinated if approved by the SGVRHT Board. To provide additional security beyond the contracts and plans, the RLF loan will be secured by a Guaranty by the developer, Cesar Chavez Foundation. The Boulevard project also has a \$2.5 million construction to permanent loan allocation from the SGVRHT. The RLF loan will be repaid prior to the issuance of this loan. Staff recommends approval of the subordination to support the project in securing the necessary funding required to acquire the site.

NEXT STEPS

If the RLF subordination is approved, staff will work with the developer to execute loan documents. The Boulevard is anticipated to close at the end of the month.

RESOLUTION NO. 23-13

RESOLUTION OF THE SAN GABRIEL VALLEY REGIONAL HOUSING TRUST (SGVRHT) APPROVING SUBORDINATION OF THE REVOLVING LOAN FUND (RLF) LOAN FOR THE BOULEVARD (Montebello)

WHEREAS, on July 18, 2023, the San Gabriel Valley Regional Housing Trust (SGVRHT) Board of Directors approved a \$4 million Revolving Loan Fund (RLF) loan for the Boulevard project in Montebello; and

WHEREAS, the RLF Guidelines define the loan terms of the RLF; and

WHEREAS, the RLF Guidelines allow for the Board to approve subordination of the RLF loan if required by the senior lender; and

WHEREAS, the senior lender for the Boulevard requires subordination of the RLF.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the SGVRHT approve the subordination of the RLF loan for the Boulevard (Montebello).
