On June 13, 2024, the San Gabriel Valley Council of Governments (SGVCOG) released the FY 24-25 Housing Solutions Fund Application. The Housing Solutions Fund provides additional assistance to cities and services providers with direct costs related to housing, rehousing, and stabilizing clients who are either at-risk or experiencing homelessness in the San Gabriel Valley. Some examples of eligible costs include rental assistance, motel vouchers, security deposit assistance, and move in costs.
